<b>Re:</b> Budget.	Consideration of recommended revision to the Requested Fiscal Year 2026

**Issue:** Consideration of recommended revision to the Requested Fiscal Year 2026 Budget.

**Suggested Motion**: I move that the Library Board authorizes withdraw of the 2026 budget request for 2.0 FTE and to convert the \$203,588 in funding into contractual services and allow for Library staff to explore other options within existing resources to provide for the needs met by these positions.

**Background:** The Library staff have internal budget processes that are conducted as part of preparing requests or changes to upcoming budgets and the 2026 recommendations were based off that work. Similarly, some of those recommendations made for 2026, once prioritized, are submitted to the Library Budget Committee and follow the Johnson County Library (JCL) Administrative Regulation 10-70-10 Library Budget Review and Approval Process. In April, the Library Board took action to approve the 2026 Library budget proposal that was created as a result of this process.

In May JCL was made aware that Johnson County was able to achieve no new County tax-funded full-time employees (FTEs) and made the library aware of the desire for alignment to also achieve no new County tax-funded FTEs. This was brought to the Library Board's attention at the May 8<sup>th</sup> Library Board Meeting and direction was given to convene a Library Budget Committee Meeting and set up a Special Library Board Meeting for the following week.

The Library Budget Committee met on May 14th and discussed the two positions that are included in the recommended 2026 Budget. The committee gained consensus around a recommendation, after considering the need for each position and the need to align with the desires of the Board of County Commissioners.

**Analysis:** After considering the need for each position and the need to align with the desires of the Board of County Commissioners, the recommendation from the Budget Committee was is to withdraw the 2026 budget request for 2.0 FTE and to convert the \$203,588 in funding into contractual services and allow for Library staff to explore other options within existing resources to provide for the needs met by these positions.

**Funding Overview:** The current recommendation should have no impact to the overall recommended FY 2026 budget as the funding is being proposed to move from compensation to contractual services.

**Alternatives:** 1) Keep the 2.0 FTE in the 2026 Budget request as originally presented and approved by the Library Board in April.

**Recommendation:** Budget Committee recommended the withdraw of the 2.0 FTE requested in the 2026 Budget and convert the funding of \$203,588 to Contractual Services to allow library staff to explore other options within existing resources to provide for the needs met by these positions.

### Purchasing Review: N/A

**Budget Review:** The request to withdraw the 2.0 FTE and convert the funding for these positions into contractual services would essentially keep the overall recommended FY 2026 Budget total similar to what was approved by the Library Board in April.
