<p>What to bring to your tax preparation site</p> <ul style="list-style-type: none"> • A Social Security card or Individual Taxpayer Identification # (ITIN) for each family member • Valid picture ID (driver’s license, state ID, passport, matrícula consular, etc.) • W-2 forms for all jobs worked in 2014 • All 1099 forms for other income, if any • Child care provider name, address, and tax ID • Any other tax-related documents received • Bank account information for direct deposit • A copy of last year’s tax return (if available) • All adults on return need to be present to sign • Affordable Care Act – Bring form 1095 from your employer, your insurance company or HHS 	<p>MCC-Maple Woods 2601 NE Barry Rd, Comp.
